Due to the requirement of numerous calculations, risk of incompatibility, and the necessity to adjust the doses for individual needs of patients with respect of current guidelines, they are more liable to errors at each stage of the PN preparation process. Therefore, the pharmacists who are involved in the provision of PN to patients in all settings must maintain appropriate nutritional skills and stay up to date with the latest guidelines, technology and knowledge in nutrition support. Sharing ideas, practical experiences and knowledge between speakers and participants and “hands on” workshops are the most important element of the Course.
